Based on suppliers confirmation we declare the lids meet the requirements of Directive 94/62, according to which the sum of the concentrations of heavy metals (Pb, Cd, Hg, Cr) does not exceed 100 ppm.

No substances added unintentionally (NIAS) were detected in quantities exceeding the permissible limits.

Adequate information relative to the substances which are subject to a restriction in food, obtained by experimental data or theoretical calculation about the level of their specific migration to enable the user of these materials or articles to comply with the relevant EU provisions or, in their absence, with national provisions applicable to food:

The substances used in the lids do not contain any dual use additives.

- 9. Specifications on the use of the material or article, such as:
- type or types of food with which it is intended to be put in contact: i)

Lids can be used for all types of food.

#### ii) time and temperature of treatment and storage in contact with the food:

Lids are used for all food types for every storage period under cooling and deep cooling conditions, as well as a storage period of up to 30 days at a temperature of up to 40°C. Not suitable for use in traditional or microwave ovens.

### iii) The contact area / volume simulant: 6 dm<sup>2</sup>/kg.
