7. Specifications on the use of the material or article, such as:

a) type or types of food with which it is intended to be put in contact:

Lunch boxes can be used as a disposable container for all kinds of food (dry, moist and fat).

a) time and temperature of treatment and storage in contact with the food:

Lunch box can be used in direct contact with food for a short time at temperatures up to 90 ° and for packing frozen food

Lunch box should be stored in a plastic bag protecting against dirt, away from devices that emit heat in a dry place, sheltered from the weather and direct sunlight at a temperature of 5 to 35 ° C and maximum humidity of 70%.

Optimal expiration date one year from the date of manufacture.

The declaration was issued on the basis of research results, and based on declarations of producers of raw materials and materials used for film production
